You are also kindly advised that if you wish to nominate please follow these procedures:

- **The Nomination Form must be signed by the President and the Secretary General of the nominating Federation and/or Confederation.**
- **The Nomination form must have the PF's / DSC's Stamp**
- **The original acceptance form must be signed by the candidate**
- **A certified copy of the nominees Identity document (not older than 3 months) must accompany the nomination and acceptance form**
- **A letter of good standing of the nominee from their federation must accompany the nomination and acceptance form**
- **All nominations must be accompanied with an Abridged CV**
- **The nominations for the positions of President as well as that of 1<sup>st</sup> and 2<sup>nd</sup> Vice President must be accompanied by the elections manifesto. A verbal summary must be presented on the day of elections.**

All documents must be put into an envelope and delivered to the GSC Secretary General, which must arrive at the GSC offices by **close of business 16:00 pm on Thursday, 19 November 2020. No late submission will be accepted.**

Members must forward in writing to the Secretary General the names of the Delegates who will represent them at Quadrennial General Meeting, by Tuesday, 01 DECEMBER 2020, on your organisation's letterhead.
